RE: Report 11 from the Coalition

Below is update number 11 from the Coalition:

It is hard to believe that it has been three months since the Morganroth Law Firm sent out their email to Mrs. Eileen McKenzie Fowler canceling her contract and ours in the process. What was disturbing was the abrupt, unprofessional, and illegal manner in which it was done. Apparently the Morganroth lawyers do not care about how it was done, and have abandoned our cause anyway. We will in time hold them accountable for our litigation fund cost payments if nothing else. The truth behind this insensitive action will be known in time. As we noted in prior reports, their inept actions has caused both law firms irreparable damage but it is working to our advantage.

As mentioned we have been carefully planning the continuance of our case against the State of Texas. We are pleased to announce that we have arrived at the next major stage, which is to bring our struggle out nationally to the public. With the expert assistance of one of our heirs, we have prepared a press release that is going out to multiple media outlets. This press release is now listed on the Voice of Change Network, and we know you will agree that it is brief, to the point, but comprehensive in highlighting the most important facts of our cause.

We have now sent the press release as a trial to The Washington Post, Texas Tribune, and Texas Observer newspapers. We are working on additional contacts and we also plan next week to send it to The Federal Bureau of Investigation (FBI) and The American Civil Liberties Union (ACLU). It is being widely distributed and needs to be in the hands of any organization willing to support us. Some of you with local media contacts might want to provide them a copy.

We will be in contact very soon with a large national law firm we believe may be interested in representing us. If enough pressure is put on State of Texas officials it may be possible they may want to work out a settlement to cut down on the adverse publicity against them. If this happens we need to have a law firm on the side willing to work out an agreement with us to deal with Texas officials. Outside of the accountability we will require from the Morganroth and Fowler law firms we will not have any more business with them.
