**NOTICE:** To the Heirs of Spanish & Mexican Land Grants  
**RE: Coalition Report – CASMLGH Update Nov. 26, 2021**

**Below is an update from the Coalition:**

Since our last report we have now submitted our press release to the New York Times, The Wall Street Journal, Propublica, (New York Investigative Journalists), The San Antonio Express-News, and The American Civil Liberties Union (ACLU). Next week we will contact The Federal Bureau of Investigation (FBI) asking them to investigate the illegal actions of the Morganroth & Fowler law firms. We will list more contacts in our next reports.

We want to emphasize that when we engage a new law firm we need to concentrate on a simple case of establishing our right under the laws for unclaimed minerals. The law firm will need to investigate two things:

1. Our right under the Texas Property law and/or Estate law also referred to as the Texas Laws of Descent and Distribution, or the “Laws of Intestacy.”
2. The whereabouts of the billions collected by the State of Texas from unclaimed mineral estates throughout Texas.

When questioned about this, state officials put forth the lie that they have in trust \$ 450,000 for us in unclaimed mineral estates in the comptroller’s office. Those are unclaimed minerals from Title Holders they cannot find. Those are not our royalties. Ours, and for many Texans, they are a Right to these minerals (not Title). The amounts collected by the state that have disappeared into the general fund amount to billions. Texas officials lie constantly to confuse the heirs, and the general public. Do not fall for this deception.

During the HB724 commission a question was asked why Texas has spent these funds on other expenditures, which they have denied. Interestingly enough the comptroller’s representative, in so many words, admitted the state had kept the funds. He said that “if that was the case,” the state would find the money to pay legitimate claims. In other words we (Texas) are using your money, but we will pay if you are a legitimate heir.

We are legitimate, but multiple claims filed by Mrs. Fowler have all been denied to date. That is why we do not need to go to the legislature to change the law, although in our lawsuit we will demand a change in the law for the future. For now, under pressure from the media, the public, and a lawsuit, Texas will have to find the money to pay our claims.
