**RE:** Report 13 from the Coalition

## **Below is update number 13 from the Coalition:**

We have now submitted our press release to the San Antonio Headquarters of The Federal Bureau of Investigation (FBI). In addition, we sent them the January 10, 1986 UPI article by G. Robert Lowry, “Oil companies, state settle suit over unclaimed royalties,” along with a reference to the article in firstsourcemediacom.com, “The Texas Spanish and Mexican Land Grant Heirs Frauded, by their Attorneys? Cries of Injustice.”

*We asked the (FBI) to investigate the possible illegal actions of the Morganroth & Fowler law firms.*

Your coalition leaders are in agreement that we do not wish the Morganroth and Fowler law firms any harm in this conflict. If wrongdoing is found, we are not interested in pressing any charges. They have caused themselves enough trouble on their own by their unprofessional and uncaring actions against our heirs.

*We simply want the return of our litigation cost fund payments in full voluntarily, and, if not, we will file a civil lawsuit and ask for damages also.*

We also want to explain a secondary purpose of these weekly coalition reports, the first being to inform and unite our base. Secondly, in case your coalition leaders are discovered, become ill, or for some reason have to give up our cause, we will need others to take over leadership and work with the Voice of Change Network work to continue our struggle and provide updates as we progress.

New leaders would only need to put these reports in the hands of interested media and lawyers, along with the various documents we have noted, such as The Getty Agreement, The UPI article, the firstsourcemediacom.com article, the attorney Fee Agreement, The Consent to Federal Litigation Form, The HB 724 documents, etc., to serve as a guide. There is now plenty of data for investigators to review.

We now have more new media and investigative organizational emails to send out the press release this weekend, and next week we will provide you the list.

Presently, we have not heard from any of our previous contacts, but realistically they cannot accept our press release at face value.

They need to conduct their own investigation, which takes time, and then they normally have to submit their reports to their lawyers to protect themselves against liability.

As always our struggle requires patience.
