NOTICE: To the Heirs of Spanish & Mexican Land Grants
RE: Coalition Report – Update #17 – Dec 31, 2021

Below is an update from the Coalition Leaders:

Dear Coalition of Adjudicated Spanish & Mexican Land Grant Heirs;

As we expected, we have had no communication from anyone this week. We are compiling more emails to send out additional press releases, and we will inform you of the recipients in our next reports. As previously noted, we will send out separate letters to the Morganroth and Fowler law firms next week to request their intentions about refunding our litigation cost fund payments with an expected answer by January 31st. We will request that repayments begin the first week in February, and, if not, by February 15th, we will proceed to file respective complaints with their state bar associations, and prepare subsequently for a civil lawsuit for recovery. It would be prudent if they would cooperate with us.

The copy of the email to Mrs. Eileen McKenzie Fowler by the Morganroth law firm terminating her contract and ours on August 18, 2021, was a totally unexpected shock. We know Mr. Mayer “Mike” Morganroth to be a man of integrity, and feel certain he had no part in this decision. His children for some reason took over, and proceeded in an illegal and unprofessional manner.

We still do not know the condition or whereabouts of Mr. Morganroth senior, but the truth will come out in the near future. Nonetheless, after shaking off the bad news, we recognized that their actions would work to our benefit. Since then we have embarked on an aggressive campaign for our cause to come out of the shadows, and orient us toward obtaining public support with a new, bigger, and more professional law firm to pick up our case. We were temporarily down, but promptly saw that the Morganroth action was a blessing in disguise.

We are very pleased that we are now reaching out to more and more adjudicated heirs thanks to the *Voice of Change Network*. We are receiving many positive comments about the detailed information we have been providing on a weekly basis. It was imperative that our heirs get this timely information, since we suffered for years with virtually no information from either law firm. The previous system of phone calls and emails to group representatives was totally ineffective.

We need, however, to clarify our relationship with the VOC Network. The volunteer heirs have owned and operated this website since 2014 due in dedication to our cause. It was fortunate that the VOC agreed to host our coalition reports for free, as we could not create our own expensive site. While the coalition leaders took over, and intend to continue our struggle; we would not be able to communicate our plans without their generous help.

We have been coordinating our efforts, but also the VOC has their own plan and agenda. Our reports are numbered at this point 1-17 and are from the Coalition. If you see a report on the VOC network that does not say it is from the Coalition, it is not from the coalition leaders. So that there is no confusion we have asked the VOC Network to headline their messages in a different manner perhaps as editorials from them. That way there will be no confusion as to the source of the message.

We are very pleased with the new players that have entered our cause; our Coalition of Adjudicated Heirs; the Voice of Change Network; the IRLEAKS Investigative reporters working independently exposing the crimes against our families; the potential support of newspapers and television stations; and other parties who will join our quest for sure. It is almost a “Perfect Storm” that will sweep us to justice, long delayed, and long denied to our people.

The coalition leaders are committed to win at all legal costs. We will not be underhanded and mistreat and abuse anyone as has been done to us, but justice must be done and all those responsible for betraying our cause will ultimately be held accountable. We prefer mediation and reconciliation to resolve our issues but we will not hesitate to use the legal system to obtain our goals. We are excited to enter the New Year with the ground work we have initiated.

We are planning to ask all our heirs to write their Texas State Representatives and Senators to inform them and ask their support of our cause, but feel that it might be better to do so sometime later in 2022. The next session of the legislature does not meet until early 2023, and, as noted previously, we do not need any new laws. We just need to inform them, and ask them to support our cause. It would be no problem if anyone chooses to inform their legislators at this time. If anyone does so, send them a copy of the press release, and refer them to the coalition reports and the VOC Network.
