**RE:** Coalition Report – Update #18 -Final Report– Jan 8, 2022

## **Below is an update from the Coalition Leaders:**

We are looking forward to this coming year as our heirs are now better informed and united, and we will proceed with an aggressive campaign to obtain, once and for all, the compensation and justice that is due our families. Our primary objective is to get our cause into the public eye. Our second is to find a large law firm to pick up our case for recovery of mineral revenues.

It was our plan to send letters of intent to The Morganroth and Fowler law firms asking them to inform us if they plan to refund the Litigation cost fund payments, and if their replies were negative or unresponsive, we would file grievances with the Texas and Michigan Bar Associations. In consultation with some attorneys they advised us to bypass the letters of intent, and immediately file grievances with both bar associations. We are presently reviewing the procedures for filing and intend to do so very soon.

We have been working with the Voice of Change Network (VOC) to reconcile our separate strategies to avoid confusion about any requirements from our heirs. The VOC has indicated they feel their postings are important, but we are sending out two separate sets of instructions.

The VOC has made it possible to inform and educate our base and the public and they are a valuable resource. We have, however, at this time, decided not to post any more coalition reports. These eighteen reports have laid out comprehensive information on our past and plans for the future. From now on we need to just keep you informed of progress. We are asking the Voice of Change Network to keep you updated, including any new information we get, which we will pass on to them, so there is only one source of information for all.

The Voice of Change has many connections that will be helpful as our heirs representing the VOC have done considerable research, as we have, over the years. We hope they can find an attorney to represent us. We are also seeking one, and if we should find one we will ask the VOC to post the proposed contract with instructions, so any heir interested can join the lawsuit. For those that will not be aware of our new law firm, it will be the firm's responsibility to find everyone eligible. They will get copies of the Declaratory Judgements that have our addresses; they may post ads in the newspaper etc. The goal is that no one will be left behind. If they cannot find everyone, part of the settlement funds will be set aside, so they can be paid later when they can be found.

This is the last report from the coalition leaders, but it should simplify the messages we send out to our heirs. The coalition leaders are very pleased that VOC was up and running to help us get organized, and to pass on the comprehensive information we have provided. That has laid a good base for the future. We will also ask the VOC that if they need any information and work on our part, we will be pleased to provide it.

While we have a high degree of confidence in our work there are no guarantees. We are opposed by powerful and wealthy individuals and organizations. The problem we have had, to simply appear in a court of law to have a judge confirm our right to unclaimed minerals, is an indication of the dark forces that do not want us to succeed. However, it will be difficult to suppress our cause when it becomes national and international news. That is now just a matter of time, especially with the forthcoming reports from the investigation being conducted by independent investigators.

We assure you that we will continue to work tirelessly on your behalf, but we needed to have a change in our communication system.
