The coalition leaders already filed their complaints months ago and are still waiting for a response. When we file our complaints, we will release a press release to local news networks so they can stay on top of the story.

Also, we are receiving too many emails from new heirs or groups who are finding us asking questions and we cannot reply to everyone we are only a few. The VOCN website has all the resources needed, if you wish to share information that helps the cause there are contact points available. There is a Q&A forum for questions, a group rep section for new groups that find us, and the news sections for the VOCN and Coalition. We need to use our time on the grievances and promoting other projects and new articles, news, and supporting information.
